With the mission of promoting and providing basic primary education to the underprivileged children in the rural parts of India, iCFDR adopted Satyawati School near town Dataganj of Badaun district, Uttar Pradesh, India. The school has around 12 classrooms, with around 450 enrolled students, from 6th to 12th standard. Apart from primary rooms, the school has 3 labs. Two classroom furniture was recently added and all the students are being funded by iCFDR. Still, there is a lot of scope for improvement.

SEWA DAY PROGRAM

An annual event was conducted on 25th December at Satyawati School, Dataganj Block, Badaun. The event was organised by Vinay ji presence of Ram Sevak Patel ji to facilitate students and encourage them. The issues addressed during the event were-

- Payment of minimum wages for daily wage farm workers a)
- b) Payment of appropriate price to farmers for crops

The event also consisted of the following activities-

- Free eye check-up camp for local villagers.
- Distribution of around 100 spectacles to villagers, who cannot b) afford them.
- c) Scholarships to around 15 students.





LIBRARY FOR SATYAWATI SCHOOL

With the aim to inculcate a sense of learning and knowledge in the students, a library was adopted in the school. The library will be equipped with books for the students as well as teachers. iCFDR started a campaign to collect used books to create a library for the students of Satyawati School.

The drive resulted in over 1,200 books being donated for the students. Both Academic as well as Non-Academic books in English and Hindi mediums were collected and donated to School.



Donating Furniture for Satyawati School



A good education system lays a strong foundation, which helps with an overall development of next generation of youth, who play a key role in facilitating growth of the country and our future. With this vision, iCFDR adopted Satyawati School and provided new furniture to the classrooms of school, iCFDR donated classroom furniture for 2-3 classrooms that includes more than 100 benches cum chairs. This is an ongoing campaign and iCFDR invites others to come forward for improving the facilities in the school for rural kids to provide education. iCFDR also planned to collaborate with other NGO's that share the same vision and are already working on meeting similar educational needs in certain rural areas.
